GCADA seeks proposals for its 22nd Annual Summit from a diverse group of experienced professionals on topics related to substance abuse prevention, early intervention, treatment, and recovery support. Presentations should include national perspectives, innovative practices, and emerging trends that offer a collaborative spirit and advocacy-driven efforts. Integration of topics that support a coordinated system of care is encouraged.

Summit Information

The 22nd Annual Summit is a free conference to be held on September 12, 2013 at the Hyatt Regency in New Brunswick. This year's theme is "Youth. Innovation. Future". The Summit seeks to educate over 800 professionals, stakeholders, and community members from across the State of New Jersey in the areas of prevention, early intervention, treatment and recovery support.

The workshops will take place in two 60-minute blocks. There will be one morning and one afternoon session. Both sessions will receive the same content.

Proposal Guidelines

Proposals must include:

- Completed Application Form (See Attached)
- Narrative: Detailed content description of the presentation must be included (may not exceed one page). Content description must detail how the presentation will impact or train to change attitudes, behaviors and/or skills while applying to the theme of the Summit. Outcomes of the content must also be indicated.
- Resume: Please make sure to include resumes for all presenters which highlight any training experience including workshops or presentations that have been facilitated within the past two years. Please include where the presentations took place and the topics covered. You may include letters of reference, articles, anecdotal accounts, and other documents that further illustrate the accomplishments of your work.
